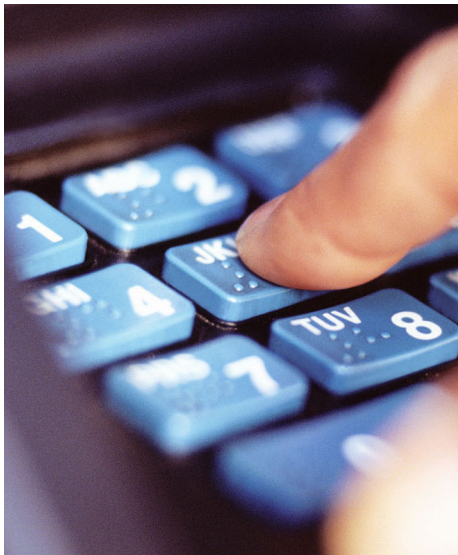

THE CHALLENGE

On March 31, 2008 the completed acquisition of Commerce Bankcorp Inc. by TD Bank Financial Group resulted in a deal that made TD Bank the seventh-largest North American bank by branches with 2,100, nearly half of which are located in North America. The deal effectively combined subsidiaries TD Banknorth of Portland, Maine and Commerce Bank of Cherry Hill, NJ, into TD Bank.

At the time of acquisition Commerce Bank had \$50 billion in assets distributed over nearly 500 branches throughout the Mid-Atlantic states and into Florida. Bringing \$58 billion in assets to the table TD Bank had come a long way from its modest beginnings as Banknorth, a small regional bank in Maine. In 2005, Banknorth was acquired by TD Bank Financial Group, a large international banking organization based in Toronto, Canada to become TD Banknorth.

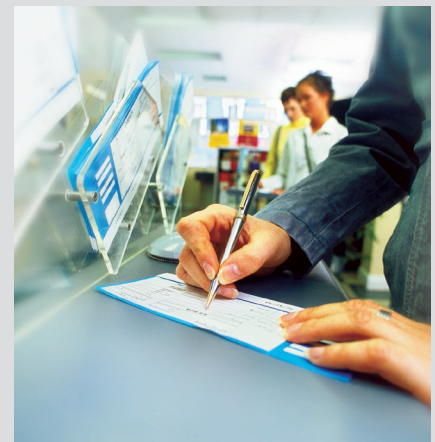
After a series of acquisitions, TD Banknorth faced a constant and critical challenge to successfully integrate the many disparate banking applications and IT systems of regional banks together into one cohesive whole. Lacking sufficient internal resources to accomplish this project, TD Banknorth ultimately determined that Global Technical Talent had proposed extremely qualified personnel at a very competitive cost.

In partnering with TD Bank on multiple IT personnel placements including network administrators, help desk and user support and an array of integration software specialists to support its Lewiston data center, Global Technical Talent has consistently delivered on its promise to deliver the best-of-the-best professional IT experts on behalf of its clients.

As the acquisition between Commerce and TD Bank progressed and the physical and logical milestones vetted, the integration of data systems gradually took center stage. Critical discussions around the evaluation of resources available internally to support that process and those that could be recruited from external sources began in earnest. Ultimately, Global Technical Talent became one of six preferred talent acquisition providers selected to recruit personnel to oversee and manage the formidable integration of these two financial heavyweights.

The projected 18-month roadmap to "go-live" integration initially required both savvy business analysts and experienced project managers. A portion

of these IT professionals were recruited by Global Technical Talent to Commerce Bank's Cherry Hill, New Jersey location (site of its former data center) and others to TD Bank's data center equivalent in Lewiston, Maine.

For Global Technical Talent the challenges were substantial. While IT professionals with deep banking and financial services experience were highly prized, experience with the industry mainframe application known as Fidelity and familiarity with ALS procedures and Integrated Monetary Processing and Control System (IMPACS) were equally sought. With its national reach, deep database reserves and industry referrals Global Technical Talent was able to successfully recruit individuals with the appropriate technical skills in both locations.

In fact, Global Technical Talent's borderless approach to talent recruitment enabled its selection as one of 40 IT staffing vendors to provide software development talent to TD Bank's Toronto, Canada headquarters, effectively becoming one of TD Bank's preferred international staffing partners.
